**ORDER GRANTING EXTENSION OF TIME  
TO TAKE AND PASS THE MPRE**


On February 23, 2015, Michael Scott Kendall (“Respondent”), filed a motion for an extension of time to take and pass the Multistate Professional Responsibility Examination (MPRE) as ordered by the California Supreme Court in order S214800, filed February 4, 2014. Pursuant to this order, Respondent has one year or, until March 8, 2015, to do so.

Since executing his stipulation, Respondent has had two opportunities to take the MPRE. He did not take the August 9, 2014 MPRE due to scheduling conflicts. He registered for but did not take the November 1, 2014 MPRE exam because he did not acquire the passport-type photograph required to allow admission to the exam. Respondent is now registered to take the MPRE on March 28, 2015 and anticipates that his results will be released on or about May 2, 2015. As such, Respondent is seeking an extension of time to May 22, 2015 to provide proof of passage of the MPRE.

Accordingly, good cause appearing, the court **GRANTS** Respondent's motion for an extension of time to May 22, 2015 for Respondent to take, pass and provide satisfactory proof of his successful passage of the MPRE. Proof of successful completion of the MPRE shall be provided to the Office of Probation.


