On June 22, 2015, Respondent filed a request for an extension of time during which she may present proof of passage of the MPRE. On June 24, 2015, the Office of Probation filed an opposition to that request, arguing that it has not been provided sufficient documentation or evidence to be able to verify Respondent's sworn statement that she has taken and failed the MPRE twice during the period of her probation.

GOOD CAUSE APPEARING and pursuant to rule 9.10(b) of the California Rules of Court, the court GRANTS Respondent's motion to extend the time during which she may present proof of passage of the MPRE. Accordingly, the time in which Respondent may and must present proof to the Office of Probation of his passage of the MPRE is extended until ten (10) calendar days after the results of the November 7, 2015 MPRE are released.

Any further request for an extension of the time to take and pass the MPRE must be accompanied by documentation showing the dates that Respondent has previously taken the MPRE unsuccessfully.


