On November 24, 2014, respondent Terri L. Brewer filed a motion for an extension of time in which to take and pass the Multistate Professional Responsibility Examination (MPRE) on the grounds of financial hardship.¹ Specifically, respondent stated that she previously had been unable to pay the cost of the examination, but was now prepared and willing to pay for the next MPRE being offered, i.e., the March 25, 2015 examination. In support of her motion respondent submitted a declaration attesting to her financial hardship.

On December 2, 2014, the State Bar of California, Office of Probation, by and through Supervising Attorney Terrie Goldade filed a non-opposition to the motion for extension.

After thorough consideration and good cause appearing, the court finds respondent's motion for extension of time is consistent with protecting the public; the member's successful

¹ In paragraph four of respondent's declaration of financial hardship, she requests that she be "given an opportunity to file another motion to be relieved of costs due to . . . financial hardship." When respondent determines that she is ready to submit such a motion, the court advises her to carefully review the Rules of Procedure of the State Bar of California, including rule 5.130, as well as all other applicable rules. As set forth in rule 5.130, a motion for cost relief must be accompanied by, among other things, a "financial statement in the form prescribed by the Court." The form to be used and the instructions for completing the form can be downloaded without charge from the State Bar of California website. rehabilitation; and maintaining the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).) Accordingly, respondent's motion is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the Multistate Professional Responsibility Examination to the Office of Probation on or before May 12, 2015.

IT IS SO ORDERED.


