On June 23, 2016, respondent filed: "Amended Motion to Extend Time to Take and Pass the MPRE and Complete State Bar Ethics School, and Stay of May 26, 2016 Suspension Order."

On June 28, 2016, respondent filed original declarations in support of the motion. On June 30, 2016, the Office of Probation of the State Bar (Probation) filed a response in opposition. On July 5, 2016, respondent filed a reply.

Finding good cause, the court grants respondent's motion and extends the time that he has to take and pass the Multistate Professional Responsibility Examination (MPRE) and to attend a session of the State Bar Ethics School and pass the test given at the end of that session. Respondent has until October 11, 2016, to provide proof of passage of the MPRE and to provide proof that he has completed State Bar Ethics School to Probation.

The suspension imposed by order filed May 26, 2016 is terminated, effective upon the filing of this order. (Cal. Rules of Court, rule 9.10(b).) This order does not limit or alter a



suspension order imposed on respondent in any other discipline or regulatory matter.<sup>1</sup>


