On May 10, 2017, the Supreme Court ordered in this matter a sixth-month period of actual suspension, effective June 9, 2017 (*In re Steven Mark Klugman* (S240205)). On May 23, 2017, respondent filed in the Hearing Department: "Application By Respondent to Postpone Effective Date of Actual Suspension," which was transferred to this court for ruling. Respondent requests that we postpone the effective date of his actual suspension until after July 20, 2017. The Office of Chief Trial Counsel of the State Bar opposes respondent's application.

Respondent has failed to show good cause pursuant to rule 5.162(F) of the Rules of Procedure of the State Bar. Respondent's motion is therefore denied without prejudice to filing an amended motion which demonstrates good cause pursuant to the rule.


