ORDER GRANTING MODIFICATION, IN PART, AND REFERRING TO REVIEW DEPARTMENT, IN PART

On April 6, 2017, respondent Charles Jeffrey Fletcher filed a motion for extension of time to complete the State Bar's Ethics School and take and pass the Multistate Professional Responsibility Examination (motion for extension).¹ On April 12, 2017, Office of Probation Supervising Attorney Terrie Goldade filed an opposition to the motion for extension. And on April 21, 2017, the Office of Chief Trial Counsel of the State Bar of California filed an additional opposition to the motion for extension.

In the motion for extension, Respondent attached proof that, on March 15, 2017, he registered for the May 2, 2017 State Bar's Ethics School. That same day, he also registered for the August 12, 2017 Multistate Professional Responsibility Examination (MPRE). The court further notes that Respondent's period of disciplinary probation in this matter runs through March 17, 2018.

After thorough consideration, the court issues the following orders:

1. Good cause having been shown, Respondent's motion for extension of time to complete the State Bar's Ethics School is **GRANTED**. Respondent is **ORDERED** to provide proof of completion of the State Bar's Ethics School to the Office of Probation by **May 9, 2017**;² and

2. Pursuant to rule 5.161(A) of the Rules of Procedure, Respondent's request for an extension of time to take and pass the MPRE, is **REFERRED** to the State Bar Court Review Department for ruling.

IT IS SO ORDERED.
