On March 6, 2014, the court filed an Order Granting Motion for Involuntary Inactive Enrollment (Order) placing Award Debtor William Walton Stewart (Award Debtor) on involuntary inactive status under Business and Professions Code section 6203, subdivision (d)(1) due to his failure to pay a fee arbitration award in full.

Thereafter, on May 5, 2014, the court held a telephonic status conference with the parties based on an issue that arose as a result of the court's review of Award Debtor's motion filed on April 9, 2014, to terminate his inactive enrollment and the State Bar's pleading setting forth its non-opposition to returning Award Debtor to active status.¹

Accordingly, following the court's May 5, 2014, telephonic status conference, the court orders the following amendment to the court's March 6, 2014, Order: In the last paragraph on


page 4 of the Order, line 4, "plus interest at the rate of ten percent per annum from June 5, 2010, the date of the last payment made by Award Debtor" is deleted.

With the exception of the amendment set forth above, the Order filed on March 6, 2014, remains unchanged.

The parties having agreed at the time of the May 5, 2014, telephonic status conference that this amendment is appropriate, this order does not affect any time limits in this matter which will be calculated from March 6, 2014, the date the Order was served on the parties.
