On March 2, 2015, Respondent Edmund Charles Gil filed a Motion to Vacate Interim Suspension requesting that his suspension be vacated because the hearing department has approved a stipulation that recommends a 90-day actual suspension. On March 20, 2015, the Office of the Chief Trial Counsel of the State Bar filed a non-opposition to Respondent's motion.

Finding good cause, the motion is granted on the ground that "substantial injustice would be done to respondent if he were 'interimly suspended' pending final disposition of his case for a greater period than the maximum discipline the deputy trial counsel could reasonably expect to obtain. . . ." (*In the Matter of Respondent M* (Review Dept. 1993) 2 Cal. State Bar Ct. Rptr. 465, 472.) Respondent's interim suspension imposed pursuant to our August 6, 2014 order is vacated on the date this order is filed. (Bus. & Prof. Code, § 6102, subd. (a); Rules Proc. of State Bar, rule 5.342(D).)

This order does not limit or alter a suspension order imposed against Respondent in any other discipline or regulatory matter.<sup>1</sup>


