On December 10, 2014, Respondent Jose Angel Trejo filed a Motion for Order Vacating Order of Interim Suspension, requesting that the court vacate the July 7, 2014 order which placed him on interim suspension effective July 23, 2014. Respondent states that on November 14, 2014, a hearing judge approved a "Stipulation Re: Facts, Conclusions of Law and Disposition," which recommended that he be placed on stayed suspension for one year and on probation for three years with conditions, including 60 days of actual suspension retroactive to July 23, 2014. Respondent contends that since the 60-day actual suspension ended on September 21, 2014, awaiting final resolution by the California Supreme Court would result in his actual suspension for a period longer than that recommended by the hearing judge. The Office of the Chief Trial Counsel of the State Bar did not find a response.

Good cause having been shown, the court's July 7, 2014 order placing Respondent on interim suspension is vacated, effective upon the filing of this order. (Bus. & Prof. Code, § 6102, subd. (a).)


