On September 14, 2016, respondent Thomas Patrick Brown IV (Respondent) filed a motion for extension of time to take and pass the Multistate Professional Responsibility Examination (MPRE). Respondent's health problems have contributed to his inability to promptly take and pass the MPRE. He plans to take the November 2016 MPRE. On September 16, 2016, Office of Probation Supervising Attorney Terrie Goldade filed a non-opposition to the motion for extension.¹

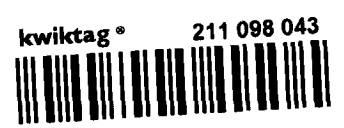
After thorough consideration, the court finds Respondent's motion for extension is consistent with protecting the public; the member's successful rehabilitation; and maintaining the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).) Accordingly, Respondent's motion for extension is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation on or before December 29, 2016.


