

Crime(s) of which convicted and classification(s): Violation of Title 18 United States Code § 371 (Conspiracy to Commit Mail or Wire Fraud in violation of Title 18 §§ 1341 and 1343), one count, a felony which involves moral turpitude as in *In the Matter of Kirwan* (Review Dept. 1994) 2 Cal. State Bar Ct. Rptr. 692 and in *In re Utz* (1989) 48 Cal. 3d 468; Title 18 United States Code §§1343 and 2 (Aiding and Abetting Wire Fraud), nineteen counts, felonies which involve moral turpitude similar to the crime in *In re Utz* (1989) 48 Cal. 3d 468; Title 18 United States Code §§1341 and 2 (Aiding and Abetting Mail Fraud), one count, a felony which involves moral turpitude as in *In the Matter of Kirwan* (Review Dept. 1994) 2 Cal. State Bar Ct. Rptr. 692 and in *In re Utz* (1989) 48 Cal. 3d 468.

3. Compliance with Rule 9.20. (Applicable only if checked.)

We bring to the Court's attention that, should the Court enter an order of interim suspension herein, the Court may wish to require the above-named member to comply with the provisions of rule 9.20, California Rules of Court, paragraph (a), within 30 days of the effective date of any such order; and to file the affidavit with the Clerk of the State Bar Court provided for in paragraph (c) of rule 9.20 within 40 days of the effective date of said order, showing the member's compliance with the provisions of rule 9.20.

4. Other information to assist the State Bar Court

Sentencing in this matter is scheduled for September 30, 2015. Upon receipt of finality of this conviction, the State Bar will be filing a request for summary disbarment.




