State Bar* (1989) 47 Cal.3d 737 [simple assault not moral turpitude *per se*]; *In re Larkin* (1989) 48 Cal.3d 236 [assault with a deadly weapon]; *In re Otto* (1989) 48 Cal.3d 970 [corporal punishment and assault]; *In the Matter of Frascinella* (Review Dept. 1991) 1 Cal. State Bar Ct. Rptr. 543 [exhibiting a replica of a firearm in a threatening manner to cause fear of harm not moral turpitude *per se*].


