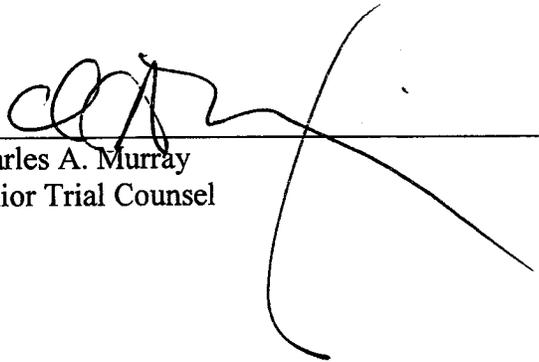
Sentencing in this matter is set for May 4, 2015. Upon receipt of proof of finality of this conviction, the State Bar will file a request for summary disbarment.

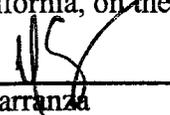
