## TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

By a stipulated motion, filed April 13, 2017, respondent Joseph Lamon Wright, represented by attorney Samuel C. Bellicini, and Senior Trial Counsel Manuel Jimenez of the Office of Chief Trial Counsel of the State Bar of California have stipulated an extension of time to pay disciplinary costs imposed by the March 7, 2017 Supreme Court order, case No. S239411.

Good cause appearing, the parties' stipulation is APPROVED. Respondent's time during which to pay the disciplinary costs in S239411 is extended and one-third of the costs must be paid with his membership fees for each of the years 2018, 2019, and 2020.
