7 Case No. 14-H-05648  
8 Rules of Professional Conduct, Rule 1-110  
[Failure to Comply with Repeval Conditions]

9 2. Respondent failed to comply with conditions attached to the private reprovall  
10 administered to respondent by the State Bar in case no. 12-O-14702 as follows, in willful  
11 violation of Rules of Professional Conduct, rule 1-110:

- 12 A. Failing to contact the Office of Probation by June 27, 2014 to schedule a  
13 meeting with respondent's assigned probation deputy;
- 14 B. Failing to pay restitution in the principal amounts of \$500 and \$1,000, plus  
15 interest of 10% per annum, to the Clerk's Office of the United States District  
16 Court for the Central District of California and provide satisfactory proof of  
17 payment to the Office of Probation by September 25, 2014;
- 18 C. Failing to timely submit to the Office of Probation two (2) quarterly reports  
19 that were due on October 10, 2014 and January 10, 2015; and
- 20 D. Failing to submit to the Office of Probation the quarterly report that was due  
21 April 10, 2015.


