**TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:**

On February 26, 2015, respondent Orion Douglas Memmott requested for extension of time to pay disciplinary costs imposed by the December 8, 2014 Supreme Court order, case No. S222036, based on his financial hardship.

On March 2, 2015, Deputy Trial Counsel Heather E. Abelson of the Office of the Chief Trial Counsel of the State Bar of California (State Bar) opposed the motion.

Respondent's request for an extension of time to pay disciplinary costs is **GRANTED**. The court hereby **ORDERS** that respondent's time during which to pay the disciplinary costs in S222036 be extended and that one-third of the costs must be paid with his membership fees for each of the years 2016, 2017, and 2018. If Orion Douglas Memmott fails to pay any installment as described above, or as may be modified by the State Bar Court, the remaining balance is due

and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.


