ORDER (1) DENYING MODIFICATION OF PROBATION CONDITION; AND (2) GRANTING EXTENSION OF TIME TO TAKE AND PASS THE MULTISTATE PROFESSIONAL RESPONSIBILITY EXAMINATION

## TO ALL PARTIES AND COUNSEL IN THE ABOVE-ENTITLED MATTER:

On January 25, 2016, respondent Shelly Ann Donachie filed a motion for modification of probation, requesting that this court waive the requirement that she take and pass the Multistate Professional Responsibility Examination (MPRE), as ordered by the Supreme Court in case No. S222829, or in the alternative, provide her with an additional two years to take and pass the MPRE.

On January 27, 2016, the Office of Probation of the State Bar of California opposed respondent's motion for modification of probation.

The requirement that respondent must take and pass the MPRE is not a probation condition. It is a Supreme Court order with which respondent must comply. This court does not have jurisdiction to vacate that order.

The court does, however, have the authority to extend the time within which respondent must take and pass the MPRE. (Cal. Rules of Court, rule 9.10(b)(1).)



Accordingly, GOOD CAUSE APPEARING, respondent's motion to extend the time within which she must take and pass the MPRE is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation on or before **September 30**, **2016**.

IT IS SO ORDERED.
