6 COUNT ONE

7 Case No. 14-O-03165  
8 Business and Professions Code, section 6068(k)  
9 [Failure to Comply With Conditions of Probation]

10 2. Respondent failed to comply with conditions attached to Respondent's disciplinary  
11 probation in State Bar Case nos. 06-O-12210 and 07-H-12920 as follows, in willful violation of  
12 Business and Professions Code, section 6068(k):

- 13 A. Failing to submit three quarterly reports by their due dates of January 10,  
14 2012, October 10, 2012, and April 10, 2013;
- 15 B. Failing to submit the quarterly report due on January 10, 2013;
- 16 C. Failing to take and provide proof of taking Ethics School by its due date of  
17 July 29, 2012;
- 18 D. Failing to take and provide proof of passage of the MPRE by its due date of  
19 July 29, 2012;
- 20 E. Failing to take and provide proof of taking four hours of in person MCLE  
21 classes in the subject of ethics by its due date of July 29, 2012; and
- 22 F. Failing to submit the final report by its due date of July 29, 2013.
