ORDER SETTING ASIDE DEFAULT AND TERMINATING INACTIVE ENROLLMENT AND DENYING RECUSAL AND TRIAL CONTINUANCE MOTIONS

By order filed-stamped January 20, 2015, this court entered default and an order enrolling LEON ARKLIAN ("Respondent"), as inactive pursuant to Rule 5.81 for failure to appear at trial on January 20, 2015. On January 30, 2015, Respondent filed a motion to set aside default on grounds of excusable neglect. The Office of Trial Counsel, represented by Deputy Trial Counsel Charles T. Calix, Esq. and Supervising Senior Trial Counsel, Ann J. Kim, Esq., opposed Respondent's motion to set aside default on the grounds that Respondent failed to meet his burden of proof and for legal and factual insufficiency. The Office of Trial Counsel also opposed Respondent's motion to disqualify Deputy Trial Counsel Charles Calix and Respondent's motion to continue trial to a date after February 9, 2015.

Good cause appearing, Respondent's motion to set aside default is **GRANTED** and the default entered on January 20, 2015, is set aside. Respondent's involuntary inactive enrollment, which was effective January 23, 2015, is terminated effective on the date of this order.



Respondent's motion to continue the trial is **DENIED as moot** and Respondent's motion to recuse Deputy Trial Counsel Charles Calix is **DENIED**.

It is further ordered that the parties shall participate in a telephonic status conference on Thursday, February 19, 2015 at 10:00 a.m.
