On December 21, 2016, the Office of Probation of the State Bar (Probation) notified this court that respondent has not filed proof of successful completion of the Multistate Professional Responsibility Examination (MPRE) within the time prescribed in the Supreme Court order filed on November 17, 2015. On December 22, 2016, respondent filed: "Application and Declaration for Order Granting Judicial Approval for Extension of Time for Successful Completion of the MPRE." On December 28, 2016, Probation filed a response in opposition.

Respondent has failed to show good cause for an extension pursuant to rule 5.162(E) of the Rules of Procedure of the State Bar. Respondent's motion is therefore denied without prejudice to filing an amended motion which demonstrates good cause pursuant to rule 5.162(E).

Under the authority of California Rules of Court, rule 9.10(b), respondent is suspended from the practice of law in this state, effective January 30, 2017, pending proof of passage, since



respondent has not passed the MPRE within the time prescribed in the Supreme Court order filed on November 17, 2015.


