ORDER EXTENDING TIME TO PAY COSTS (Bus. & Prof. Code, § 6086.10, subd. (c).)

These matter are before the court on Attorney Juliet Monique Oberding's March 9, 2018, motion for relief from or extension of time to pay disciplinary costs. The Office of Chief Trial Counsel of the State Bar of California oppose Oberding's motion for relief from costs, but does not oppose her motion for an extension of time to pay costs.

Oberding has failed to establish sufficient hardship, special circumstances, or other good cause to grant her relief from any of the disciplinary costs assessed against her in either case number 14-O-05179-LMA (S228456) or case number 17-O-01375-LMA (S244512).

Nonetheless, Oberding has established sufficient hardship, special circumstances, and other good cause to extend the time in which she must pay the disciplinary costs assessed against her in both of those cases.

ORDER

The court orders that Juliet Monique Oberding's March 9, 2018, motion for relief for disciplinary costs is DENIED, but that her March 9, 2018, alternative motion for an extension of time to pay disciplinary costs is GRANTED as follows. The time in which Juliet Monique



Oberding must pay the costs imposed on her under the Supreme Court's October 20, 2015, order in *In re Juliet Monique Oberding on Discipline*, case number S228456 (State Bar Court case number 14-O-05179) and the time in which she must pay the costs imposed on her under the Supreme Court's December 13. 2017, order in *In re Juliet Monique Oberding on Discipline*, case number S244512 (State Bar Court case number 17-O-01375) are both EXTENDED as follows: One-fifth of the costs must be paid with Juliet Monique Oberding's annual State Bar membership fees for each of the years 2019, 2020, 2021, 2022, and 2023. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).) If Juliet Monique Oberding fails to pay any installment as described *ante*, or as may be modified by the State Bar Court under Business and Professions Code section 6086.10, subdivision (c) and the Rules of Procedure of the State Bar, rule 5.134.) Until they are paid in full, the costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
