
On April 21, 2016, Respondent filed a motion to further extend the time for him to take and pass the MPRE. In his motion, he stated that he took but failed to pass the March 19, 2016 MPRE. He then asked that the deadline for his MPRE compliance be extended to allow him to take the August 2016 MPRE examination. That request was opposed by the Office of Probation in an opposition filed April 25, 2016.

On April 29, 2016, this court issued an order finding that, if Respondent took but failed to pass the March 2016 MPRE, good cause exists to further extend the deadline for him to pass the examination. However, because Respondent had failed to include with his motion "documentation and evidence regarding Respondent's prior efforts to take and pass the MPRE," as required by a prior order of this court, Respondent was given until May 10, 2016, to provide to this court and the Office of Probation documentary evidence that he enrolled in and took the March 2016 MPRE, including but not limited to a copy of the report of the results he received of his taking of that examination. The order further stated that, in the event that documentary evidence, satisfactory to this court, is received on or before that date, Respondent's motion for a further extension will be granted. If not, the request will be denied.

On May 3, 2016, Respondent served and filed satisfactory evidence that he had taken, but not passed, the MPRE. Accordingly, his motion for an extension of time is GRANTED. Accordingly, the time in which Respondent may and must present proof to the Office of Probation of his passage of the MPRE is extended until ten (10) calendar days after the results of the August 2016 MPRE are released.

IT IS SO ORDERED.
