Accordingly, the time in which Respondent may and must present proof to the Office of Probation of his passage of the MPRE is extended until ten (10) calendar days after the results of the March 19, 2016 MPRE are released.

Any further requests for an extension of the MPRE deadline must be accompanied by documentation and evidence regarding Respondent's prior efforts to take and pass the MPRE.


