**ORDER GRANTING RESPONDENT'S  
MOTION TO MODIFY PROBATIONARY  
CONDITION RE: PAYMENT OF  
INTEREST TO DECEASED PAYEE**

On December 14, 2018, Lee Alan Gross (Respondent), filed a motion to modify probationary condition re: payment of interest to deceased payee (CRC 9.10) (c) and RPC 5.300 (motion). The Office of Chief Trial Counsel (OCTC) filed a response on December 21, 2018. By his motion, Respondent requests that this court modify the Supreme Court order filed in case No. S229786, on December 16, 2015, to require the interest Respondent was ordered to pay to his former client, Robert Simoneau, to be paid to the Client Security Fund of the State Bar of California, since Mr. Simoneau is deceased.

For good cause shown, this Court **GRANTS** Respondent's motion. It is further ordered that Respondent shall pay the outstanding interest owed to Mr. Simoneau to the Client Security Fund by January 30, 2019, and Respondent shall provide the Office of Probation proof of payment no later than February 4, 2019.


