This matter is before the court on the Mandip Singh Purewal's June 1, 2017, motion to extend the time in which to pass the Multistate Professional Responsibility Examination. On June 7, 2017, the State Bar of California's Office of Probation filed an objection to Purewal's motion.

Under the Supreme Court's May 18, 2016, order in *In re Mandip Singh Purewal on Discipline*, case number S233103 (State Bar Court case number 14-O-04814, etc.), Purewal was required to take and pass the Multistate Professional Responsibility Examination (MPRE) and to provide satisfactory proof of such passage no later than June 17, 2017. Purewal seeks to extend that time until December 17, 2017.

In his motion, Purewal states that he is registered to take the MPRE on August 12, 2017. The court will extend the time to permit him to take that examination.

ORDER

The court orders that Mandip Singh Purewal's June 1, 2017, motion is GRANTED to the extent that the time in which he must take and pass the Multistate Professional Responsibility Examination and provide proof of his passage to the State Bar's Office of Probation under the Supreme Court's May 18, 2016, order is EXTENDED from June 17, 2017, until September 26, 2017. (Cal. Rules of Court, rule 9.10(b)(1); Rules Proc. of State Bar, rules 5.161(A)(2).)


