On May 22, 2017, respondent James Lissant Conkey (Respondent) filed a motion seeking reconsideration of a portion of the court's May 15, 2017 order granting him an extension of time to take and provide proof of passage of the Multistate Professional Responsibility Examination (MPRE). Specifically, Respondent seeks reconsideration of the deadline for Respondent to provide proof of passage of the MPRE to the Office of Probation and requests that the last sentence of the court's May 15, 2017 order be stricken and that certain language providing that Respondent provide proof of passage of the MPRE to the Office of Probation within 10 calendar days after the release of the results of the August 12, 2017 examination be substituted in its place.


The State Bar's Office of Probation filed a response to Respondent's motion on May 30, 2017. The Office of Probation does not oppose Respondent's motion.

After reviewing and considering Respondent's motion and the Office of Probation's response thereto, and good cause having been shown, Respondent's motion for reconsideration is **GRANTED**. However, the court finds it appropriate and set a date certain by which proof of

passage of the MPRE must be provided to the Office of Probation. The court therefore orders that the last sentence of the court's May 15, 2017 order is stricken, and in its place is substituted the following language: "Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation on or before **Friday, September 29, 2017.**"

**IT IS SO ORDERED.**
