On August 25, 2014, respondent Swazi Elkanzi Taylor (respondent) filed a Memorandum of Points and Authorities¹ seeking his inactive enrollment under Business and Professions Code section² 6007, subdivision (b)(1), asserting a claim of mental incompetence and that he is unable to assist counsel in his own defense. Respondent also requested that the court abate all disciplinary proceedings pending against him.

At a settlement conference on August 26, 2014, respondent again requested to be placed on inactive status under section 6007, subdivision (b)(1).

The State Bar of California, Office of the Chief Trial Counsel, does not oppose respondent's request to be placed on inactive status.

As the evidence clearly and convincingly demonstrates that an order under section 6007, subdivision (b)(1) is appropriate, respondent's motion is granted. Respondent is ordered enrolled as an inactive member of the State Bar of California under section 6007, subdivision (b)(1) and rule 5.172(A) of the Rules of Procedure of the State Bar, effective three days after service of this order.

The court hereby appoints the law firm Pansky Markle Ham LLP to represent respondent in any further proceedings in this matter. The address and telephone number for Pansky Markle Ham LLP are: 1010 Sycamore Avenue, Unit 308, South Pasadena, California 91030, (213) 626-7300.

PLEASE TAKE NOTICE that a status conference, concerning the above-entitled matter will take place on September 22, 2014, at the hour of 10:00 a.m. The status conference will be held telephonically and audio recorded. The call will be placed by the case administrator to the telephone number of record for the assigned deputy trial counsel and for respondent's appointed counsel unless the case administrator is notified of a different telephone number at which the deputy trial counsel or respondent's appointed counsel may be reached at least 24 hours prior to the scheduled date and time of the conference.
