

On October 25, 2018, respondent Glen Timothy Neal filed a motion for extension of time to take and pass the Multistate Professional Responsibility Examination and the State Bar's Ethics School (motion for extension). On November 1, 2018, Office of Probation Supervising Attorney Terrie Goldade filed an opposition to the motion for extension.

The court has carefully considered the motion and opposition. The court determines that Respondent's motion for extension is consistent with protecting the public, Respondent's successful rehabilitation, and maintaining the integrity of the legal profession. (Rules Proc. of State Bar, rule 5.300(B).) Accordingly, the court issues the following orders:

(1) Good cause having been shown, Respondent's motion for extension of time to complete the State Bar's Ethics School is **GRANTED**. Respondent is **ORDERED** to provide proof of completion of the State Bar's Ethics School to the Office of Probation by **April 16, 2019**.



(2) Good cause having been shown, Respondent's motion to extend the time within which he must prove passage of the Multistate Professional Responsibility Examination (MPRE) to the Office of Probation is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of the MPRE to the Office of Probation by **May 13, 2019**.


