18 I humbly apologize for my delay in responding, however, I had not retrieved my mail for  
19 a week or two and did become aware of this order until the 2nd of October, 2015. As I had  
20 previously received notice via email from the Chief Trial Counsel for the State Bar's office of  
21 the change in status of this matter on September 3, 2015, I wrongly assumed I would have  
22 received notice via email of subsequent proceedings, including that of September 15, 2015.  
23 However, I did not receive them electronically, so it wasn't until I retrieved my mail that I  
24 became aware of the Order.

26 In any event, I want the State Bar Court to understand that I do not take exception to any




1 wanted the State Bar to know that as a result of my conviction I spent two weeks in jail and  
2 forty-five (45) days on an ankle monitor as per the court's order. As of today's date, I am just  
3 under half way through my 5 year probation ordered by the Placer County Superior Court  
4

5 In addition, since first appearing before the Placer County Superior Court in the  
6 underlying case, I attended Alcoholics Anonymous meetings three (3) times per week from  
7 January 2013 until February 2015, not missing a single one of my required meetings. In February  
8 2015, the Court reduced my Alcoholics Anonymous attendance requirement to one (1) meeting  
9 per week, which I have faithfully done since February 18, 2015, not missing a single week. I  
10 have paid all of my court fees/fines and restitution has been made to the injured parties. I have  
11 checked-in with Placer County Probation each and every time I have been required to do so and  
12 have strictly adhered to each and every term and condition of my probation since they were  
13 instituted.

15 I am sincerely remorseful for my actions and would ask the State Bar Court to please take  
16 into account all of the foregoing when determining the level of discipline that should be imposed  
17 in my case.


