3. Compliance with Rule 9.20. (Applicable only if checked.)

We bring to the Court's attention that, should the Court enter an order of interim suspension herein, the Court may wish to require the above-named member to comply with the provisions of rule 9.20, California Rules of Court, paragraph (a), within 30 days of the effective date of any such order; and to file the affidavit with the Clerk of the State Bar Court provided for in paragraph (c) of rule 9.20 within 40 days of the effective date of said order, showing the member's compliance with the provisions of rule 9.20.

4. Other information to assist the State Bar Court

Previously, on June 5, 2003, Respondent was convicted of Vehicle Code §23103 (Reckless Driving – Non-Alcohol related), a misdemeanor, a count added by interlineation. The charges of the complaint: Vehicle Code §23152(a) (Driving Under the Influence - Alcohol or Drugs), a misdemeanor; and Vehicle Code §23152(b) (Driving with Blood Alcohol Level of .08% or more), a misdemeanor, were dismissed. On October 29, 2012, upon the termination of probation and Respondent's motion, the Court set aside and vacated the finding of guilty and dismissed the complaint pursuant to Penal Code §1203.4. Because the court clerk has declined to complete the State Bar's Notice of Lack of Appeal form, the complete docket certified on February 29, 2016 is being presented as proof that no party has filed an appeal within 30 days after pronouncement of Judgment on September 18, 2007 (See Cal. Rules of Court, rule 8.853).


