4. Other information to assist the State Bar Court

On February 17, 2016, PC273.5(a), count one, was reduced to a misdemeanor, per PC17b. Respondent then pled guilty to count one and the remaining counts were dismissed. In the plea, Respondent stipulated to the Preliminary Exam as a factual basis to the plea. Therefore, the certified Preliminary Exam transcripts of August 11, 2015 are being transmitted as part of the conviction record. The San Diego Superior Court clerk declined to complete the State Bar's Lack of Appeal form. Instead, the court provided the San Diego Court's Criminal Record Search form certified on April 15, 2016 reflecting that no party has filed an appeal.




