We bring to the Court's attention that, should the Court enter an order of interim suspension herein, the Court may wish to require the above-named member to comply with the provisions of rule 9.20, California Rules of Court, paragraph (a), within 30 days of the effective date of any such order; and to file the affidavit with the Clerk of the State Bar Court provided for in paragraph (c) of rule 9.20 within 40 days of the effective date of said order, showing the member's compliance with the provisions of rule 9.20.

4. Other information to assist the State Bar Court

On October 6, 2015, the original charges in the complaint: Penal Code §245(a)(1) (Assault with a Deadly Weapon – Tire Iron), a misdemeanor; and Penal Code §417(a)(1) (Willfully and Unlawfully Draw and Exhibit a Deadly Weapon – Tire Iron), a misdemeanor, were dismissed. Because the court clerk has declined to complete the State Bar's Notice of Lack of Appeal form, the complete docket certified on February 9, 2016 is being presented as proof that no party has filed an appeal within 30 days after pronouncement of Judgment on October 6, 2015 (See Cal. Rules of Court, rule 8.853) or within 60 days after pronouncement of Judgment (See Cal. Rules of Court, rule 8.308).


