Respondent failed to file a declaration of compliance with California Rules of Court, rule 9.20 in conformity with the requirements of rule 9.20(c) with the clerk of the State Bar Court by September 24, 2015, as required by Supreme Court order no. S211926, in willful violation of California Rules of Court, rule 9.20. (A true and correct copy of the rule 9.20 order is attached hereto as Exhibit 1 and is incorporated by reference.)




In re ZACHARY ALEXANDER TORAN on Discipline

The court orders that the probation of Zachary Alexander Toran, State Bar Number 267822, is revoked. The court further orders that:

1. Zachary Alexander Toran is suspended from the practice of law for a minimum of three years, and he will remain suspended until he provides proof to the State Bar Court of his rehabilitation, fitness to practice and learning and ability in the general law. (Rules Proc. of State Bar, tit. IV, Stds. for Atty. Sanctions for Prof. Misconduct, std.1.2(c)(1).)
2. Zachary Alexander Toran is given credit towards the three years' suspension for the period of involuntary inactive enrollment which commenced on April 23, 2015.

Zachary Alexander Toran must also comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 calendar days, respectively, after the effective date of this order. Failure to do so may result in disbarment or suspension.

Costs are awarded to the State Bar in accordance with Business and Professions Code section 6086.10 and are enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
