On May 18, 2016, the Supreme Court issued an order in the captioned matter, disciplining Respondent and ordering her to pay costs. This order imposing costs, however, allowed Respondent to pay costs in installments, with one-third of the costs to be paid with Respondent's membership fees for each of the years 2017, 2018, and 2019.

On June 16, 2017, Respondent filed a motion requesting a six-month extension, to December 21, 2017, of the time for her to pay the first installment of her cost obligation, due with her membership fees for 2017.

On June 20, 2017, the State Bar filed a statement of non-opposition to the request.

GOOD CAUSE having been shown, Respondent's obligation to pay costs is hereby modified and extended as follows: the sum of the disciplinary costs currently still owed will be paid in three equal installments, with one-third of that remaining balance to be paid by Respondent on December 31, 2017; and the remaining two installments to be paid on or before each of the deadlines for payment of membership fees for the years 2018 and 2019, respectively. If Respondent fails to pay any of the above installment payments more than 10 days after its due date without the prior written approval of the State Bar or the State Bar Court, the remaining unpaid balance of the costs will be due immediately and be enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.
