

Barry L. Van Sickle (hereinafter "Respondent") Answers and responds to the Notice of Disciplinary Charges, and the allegations made therein, as follows:

1. In response to paragraph #1 of the Notice, Respondent admits to the jurisdiction of this court, admits that he was admitted to practice law in the State of California on July 10, 1981, and admits to being a member at times pertinent to these charges and being a current member of the State Bar of California.
2. Paragraph 2 is admitted except that Respondent denies being in willful violation of Business and Professions Code, section 6080 (k). Respondent affirmatively avers that any claimed violation of said Code is inadvertent and due to circumstances beyond his immediate control.
3. Respondent's Adjusted Gross Income as shown on tax returns was \$3,720 for 2013 and \$3,597 for 2014.



- 1 4. Respondent's work income for the first six months of 2015 was
2 approximately \$2,000.
- 3 5. Respondent has been working full time in a position that was expected to
4 generate a much higher income in 2014 and 2015, and was expected to
5 generate sufficient income to pay Respondent's bar dues, bar costs and the
6 restitution in question by applicable due dates. This has not happened for
7 reasons beyond Respondent's control.
- 8 6. Respondent has no assets of value or ability to borrow significant sums.
9 Respondent has insufficient funds or income to pay the restitution in
10 question. Respondent is not insolvent by choice.


