28 Respondent **DENIES** each of the allegations set forth in Count One, paragraph 2 of the NDC.

2 (“Thibodeaux”) for the purposes of signing an attorney client agreement and collecting fees plus costs

7 [Moral Turpitude]

8 Respondent **DENIES** each of the allegations set forth in Count Two, paragraph 3 of the NDC.

9 Respondent **ADMITS** that on November 7, 2014 she met with her client George Thibodeaux
10 (“Thibodeaux”) for the purposes of signing an attorney client agreement and collecting fees plus costs
11 totaling \$5,500.00. Respondent **DENIES** that she engaged in an act involving moral turpitude,
12 dishonesty, and corruption when she met with Thibodeaux on November 7, 2014.

14 COUNT THREE

15 Business and Professions Code § 6068(a)
16 [Failure to Comply With Laws –Unauthorized Practice of Law]

17 Respondent **ADMITS** that on December 23, 2014, Respondent prepared and filed a civil
18 complaint for wrongful termination against Thibodeaux’s former employer on his behalf. Respondent
19 **ADMITS** that when she prepared and filed Thibodeaux’s complaint, Respondent was on involuntary
20 inactive status.
