ORDER MODIFYING PROBATION CONDITION (RESTITUTION)

### TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

By motion filed December 28, 2017, respondent Charles Jeffrey Fletcher requested to modify the probation condition to extend the time within which he could pay restitution based on financial difficulties. Specifically, he asked for an extension of four months to pay the restitution, beginning March or April 2018. He also asked that this motion be filed under seal.

On January 10, 2018, the Office of Probation of the State Bar of California, represented by supervising attorney Terrie Goldade (Office of Probation), opposed the requests.

Having carefully considered respondent's motion and the Office of Probation's response, the court concludes that respondent's financial condition warrants an extension of time to begin the installment restitution payments.

Good cause appearing, the court **GRANTS** respondent's motion for an extension of time to pay restitution and **ORDERS** that the probation condition of restitution be modified, such that respondent must pay the monthly installment restitution payment of \$430 beginning **May 1**, **2018**, to Sandra F. Smith and provide satisfactory proof of payment to the Office of Probation with each quarterly probation report, or as otherwise directed by the Office of Probation. If respondent fails to pay any installment, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

Respondent's request to seal his motion and its attachments is **DENIED**. The motion was not supported by any specific facts showing that a statutory privilege or constitutionally protected interest exists that outweighs the public interest in the proceeding. (Rules Proc. of State Bar, rule 5.12.)
