

On April 26, 2019, the California Supreme Court issued its order of discipline in this case, including that respondent Gabriel Castellanos be actually suspended for six months, effective May 26, 2019.

On May 20, 2019, respondent filed a motion to delay or stay the actual suspension until after June 26, 2019, asserting he has some cases to conclude before his suspension begins.

On May 29 2019, the Office of Chief Trial Counsel of the State Bar filed a notice of non-opposition to respondent's motion to delay or stay the actual suspension.

For good cause appearing, and in view of OCTC's non-opposition, respondent's motion is granted. (Rules Proc. of State Bar, rule 5.162 (D).) His suspension is hereby stayed effective upon the filing of this order and until July 1, 2019. Respondent must notify his clients and the tribunals within 5 days of this order of his impending suspension, and also inform OCTC forthwith thereafter that he has completed these notifications.


