TO ALL PARTIES AND COUNSEL IN THE ABOVE-ENTITLED MATTER:

On May 11, 2018, Deputy Trial Counsel Laura Huggins of the Office of Chief Trial Counsel of the State Bar of California (OCTC) filed a motion to modify the stipulation, filed May 8, 2018. (Rules Proc. of State Bar, rule 5.58(F).) OCTC asked the court to modify the court's order approving the stipulation as modified and reinstate two of the deleted probation conditions, namely, the "actual suspension and until payment of restitution" and the conditional standard 1.2(c)(1) provisions, to reflect the true intent of the parties. Respondent George Anthony Munoz agrees to the request.


Accordingly, the motion to modify the stipulation is granted in that the court's May 8, 2018 order approving the stipulation as modified is hereby **VACATED**, and the court now renders the following modification order:

Finding the stipulation to be fair to the parties and that it adequately protects the public, IT IS ORDERED that the stipulated facts and disposition are APPROVED AS MODIFIED as set forth below, and the DISCIPLINE IS RECOMMENDED to the Supreme Court.

1. On page 7, under "a. Restitution," in the first paragraph, delete the date "August 17, 2016" and change it to "July 31, 2017," so that interest accrues from July 31, 2017, as that was the last date of installment payment of attorney fees.
2. On page 7, under "a. Restitution," in the second paragraph, delete the language beginning with "not later than 120 days prior to the expiration of probation..." until the end of the paragraph.

IT IS SO ORDERED.


