By motion filed November 21, 2017, **THOMAS PATRICK BROWN IV** (Respondent), sought an extension of time to comply with the order assessing disciplinary costs in State Bar Court case no. 15-O-15428. (Rules Proc. Of State Bar, rule 5.130(B)) Respondent's motion was based on financial hardship. On November 27, 2017, the Office of the Chief Trial Counsel of the State Bar of California (State Bar) filed a notice of non-opposition to Respondent's motion.

After reviewing the parties' pleadings, the court issues the following orders:


1. Respondent's request for an extension of time to comply with the order to pay disciplinary costs is **GRANTED** in view of Respondent's financial hardship and for good cause shown. The court orders that Respondent's time to commence payment of disciplinary costs associated with case no. 15-O-15428, be extended by three years. Respondent's disciplinary costs shall be paid in three equal installments with Respondent's annual State Bar membership fees for the years 2019, 2020 and 2021.
2. The court further orders that, if Respondent fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules Proc. Of State Bar, rule 5.134.



The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


