On December 14, 2017, Raymond Roy Miller (respondent) filed a petition seeking relief from paying the disciplinary costs in this matter, or in the alternative, an extension of time to pay the disciplinary costs. (Rules Proc. of State Bar, rule 5.130.) On December 27, 2017, the Office of Chief Trial Counsel of the State Bar of California (State Bar) filed a response stating that it does not oppose an extension of time to pay the disciplinary costs so long as the extension does not go beyond February 2019. Then, on January 3, 2018, the State Bar filed another response to the petition, now opposing any relief from the payment of disciplinary costs including an extension of time to make the payment. Respondent filed a reply on January 16, 2018.

Having carefully considered respondent's requests and the State Bar's responses, the court **DENIES** respondent's request for full relief from payment of the disciplinary costs. However, the court finds that respondent has established hardship, special circumstances, and other good cause under rule 5.130(B) of the Rules of Procedure of the State Bar that warrants an extension of time for respondent to pay the disciplinary costs in this matter. Therefore, the court **GRANTS** an extension and **ORDERS** respondent to pay all outstanding disciplinary costs in this matter by February 1, 2019. (Bus. & Prof. Code, § 6086.10, subd. (c).) The court further

ORDERS that if respondent fails to pay the disciplinary costs as described above, or as may be modified by the State Bar Court, the remaining balance of the costs is due and payable immediately. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


