[Failure to Comply With Conditions of Probation]

9 2. Respondent failed to comply with conditions attached to respondent's disciplinary
10 probation in case no. 11-O-16029-PEM as follows, in willful violation of Business and
11 Professions Code, section 6068(k):

- 12 A) Failing to timely submit 5 quarterly reports by their due dates of October 10,
13 2013, April 10, 2014, October 10, 2014, January 10, 2015, July 10, 2015; and
14 B) Failing to timely submit a final report by its due date of August 9, 2015; and
15 C) Failing to provide proof of payment of \$7,750 in sanctions ordered pursuant to
16 the Judgment and Supplemental Memorandum re Motion for Sanctions, filed
17 on December 17, 2009, in *In re Peterson and Erb, Inc., dba Comptech*, United
18 States Bankruptcy Court, Eastern District of California, case no. 07-23766-C-
19 7, by the due date of August 9, 2015.


