14 Kenneth E. Ostrove, Respondent herein, supplements his Probation Revocation
15 Response, as follows:

16 1. Restitution to Sherry van Dyk.

17 On November 20, 2015, Respondent mailed to Ms. Van Dyk the check for restitution,
18 along with a receipt to sign and return to Probation. Attached hereto as Exhibit "A" is a copy of
19 the letter, receipt, and cancelled check.

20 2. Efforts to Comply with Terms of Probation.

21 The State Bar argues that failure to comply with probation demonstrates a lack of concern
22 about professional responsibilities. On June 24, 2015, Respondent requested a stipulation to
23 extend the time to pay restitution, file the LOMP, and file the Rule 9.20 Declaration. Probation
24 declined that request. Attached hereto as Exhibit "B" are copies of the E-mail to and from
25 Probation regarding an extension.

26 Respondent timely filed the Rule 9.20 Declaration. As set forth in the original Response,
27 Respondent was working on the LOMP and Quarterly Report. Respondent's daughter was

1 injured on June 26, 2015. As the due dates were coming up, Respondent communicated with
2 Probation, requesting an extension. This demonstrates Respondent was making effort to comply
3 with the Probation terms rather than a lack of concern.


