On October 27, 2017, a Stipulation Re Facts, Conclusions of Law and Disposition (Stipulation), as well as an order of involuntary inactive enrollment and an order approving the Stipulation, as supplemented by the parties' supplement which was filed on October 20, 2017 and attached to the order, was filed in the above-entitled matter.

Thereafter, on November 15, 2017, the Office of Chief Trial Counsel of the State Bar of California (OCTC) filed a Notice of Errata Regarding Omission of Disciplinary Costs

Assignment in Stipulation Re Facts, Conclusions of Law, and Disposition (Notice). In the Notice, the OCTC noted that the Stipulation "failed to assign disciplinary costs to respondent pursuant to Business and Professions Code, section 6086.10."

In pertinent part, Business and Professions Code section 6086.10 states, "In an order imposing discipline . . . the Supreme Court shall include a direction that the member shall pay

costs." On page 2 of the Stipulation, the parties failed to check any box under paragraph A.(8) regarding payment of disciplinary costs.¹

Therefore, pursuant to Business and Professions Code section 6086.10, the order approving the Stipulation as supplemented by the parties supplement filed on October 20, 2017, is hereby MODIFIED to include the following modification:

On page 2 of the Stipulation, at paragraph A.(8), an "X" is inserted in the box next to "Costs to be awarded to the State Bar."

Any objection to this modification order must be filed within 15 days of its service. If no timely objection is filed, the stipulation and supplement as modified remains approved, and a staff member of the State Bar Court is directed to transmit the record in this matter to the Supreme Court without further delay.
