On July 2, 2018, Lawrence Jacob Song, filed a motion to vacate his interim suspension ordered December 15, 2017, (effective January 8, 2018) due to his felony conviction. The motion asserts that the parties reached a stipulation for discipline that includes a 60-day actual suspension, and respondent has served more than that time on interim suspension. On July 10, 2018, the Office of Chief Trial Counsel of the State Bar filed a response, stating no objection to respondent's request if the Hearing Department files an order approving the parties' June 29, 2018 stipulated discipline. We have confirmed that that stipulation recommending discipline including a 60-day suspension was filed by the Hearing Department on July 16, 2018.

Good cause appearing, respondent's motion is granted. (Rules Proc. of State Bar, rule 5.342(D).) The suspension imposed by order filed December 15, 2017, is vacated, effective upon the filing of this order. This order does not limit or alter a suspension order, if any, imposed on respondent in another discipline or regulatory matter.


