- 2. The court further orders that, if Respondent fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules Proc. Of State Bar, rule 5.134.

The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
