On August 13, 2018, the Office of Chief Trial Counsel of the State Bar (OCTC) submitted a transmittal indicating that respondent Berj Boyajian, State Bar Number 60631, has been convicted of violating Penal Code section 134 (preparing false documentary evidence), a felony involving moral turpitude and Business and Professions Code section 6128, subdivision (a) (deceit or collusion with intent to deceive the court or any party), a misdemeanor involving moral turpitude. It is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law, effective October 1, 2018, pending final disposition of this disciplinary proceeding. (Cal. Rules of Court, rule 9.10, subd. (a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension. Within 120 days of the date of this order, OCTC is ordered to submit evidence of finality or provide an update on finality.


