On March 5, 2019, the Office of Chief Trial Counsel of the State Bar (OCTC) filed a Transmittal of Records of Conviction of Gregory Ford Gilbert. OCTC incorrectly noted the conviction and was ordered to re-file its transmittal. On March 28, OCTC filed a supplemental report correctly stating that Gilbert had been convicted of violating title 18 United States Code section 371 (conspiracy), where the object of the conspiracy was to violate title 18 United States Code section 666(a)(2) (bribery concerning a program receiving federal funds), a felony. We have not received evidence of finality. On April 15, 2019, Gilbert filed an initial response to the OCTC's supplemental report, but on April 16, 2019, it was rejected for filing by the court clerk of the Review Department due to various service deficiencies.

Since Gilbert's conviction is a felony, it is ordered pursuant to Business and Professions

Code section 6102 that respondent be suspended from the practice of law effective May 13,

2019, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is also
ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts
specified in subdivisions (a) and (c) of that rule in 30 and 40 days, respectively, after the
effective date of this suspension.

Since we have not classified this conviction before, we reserve on classification and permit the parties an opportunity to brief that issue. Within 10 days of the date of this order, OCTC is to provide analysis and legal support regarding its contention that the Gilbert's conviction is a crime that involves moral turpitude per se under California analogous law. Respondent will have 10 days from the service of OCTC's filing to respond.
