) PARTIES STIPULATION

On March 25, 2019, the Office of Chief Trial Counsel of the State Bar of California (OCTC) and Respondent Jessica Warne filed a stipulation for Respondent's transfer to inactive enrollment pursuant to Business and Professions Code (Bus. and Prof. Code) section 6007(b)(1), and for abatement of all current and future proceedings against Respondent until this court issues an order terminating Respondent's involuntary inactive enrollment. On March 25, OCTC also filed a motion to seal the parties' stipulation because the stipulation contained Respondent's confidential medical information. Respondent did not file a response to the motion.

Respondent has stipulated that she is unable to practice law competently without posing a substantial threat of harm to the interests of clients or to the public and that she is presently unable to assist counsel in her defense of a disciplinary proceeding. In addition to the stipulation, Respondent has indicated in a separate letter to this court that she is suffering from "severe mental health issues."



Respondent has acknowledged that she understands that she will not be allowed to practice law until she petitions this court for transfer to active enrollment status, and until the court grants the petition based on a finding that there is no longer a basis for the inactive enrollment.

This court has determined that, under the circumstances, no additional procedural steps are required before an order may be issued pursuant to Bus. and Prof. Code section 6007(b)(1). As a result of Respondent's stated inability to assist in the defense of case nos. 18-O-14954; 18-O-15241; 18-O-15649; 18-O-15867, it is ordered that Respondent be enrolled as an inactive lawyer of the State Bar of California pursuant to Bus. and Prof. Code section 6007(b)(1), effective three days after service of this order by mail. (Rules Procedure of State Bar of California, rule 5.172.) The State Bar Court staff is directed to give written notice of this order to Respondent and counsel for OCTC.

The abatement order filed on February 25, 2019, in case nos. 18-O-14954; 18-O-15241; 18-O-15649; 18-O-15867 remains in effect and any future disciplinary matters are abated until further order of this court.

In addition, good cause having been shown, OCTC's motion to seal is **GRANTED**. Accordingly, the Stipulation Regarding Enrollment of Respondent Jessica Warne to Inactive Status Pursuant to Bus. and Prof. Code section 6007(b)(1) and the attached documents filed March 25, 2019, are ordered sealed.

It is further ordered that protected and sealed material will only be disclosed to: (1) parties to the proceeding and counsel; (2) personnel of the Supreme Court, the State Bar Court and independent audiotape transcribers; and (3) personnel of the Office of Probation when necessary for their official duties. Protected material will be marked and maintained by all authorized individuals in a manner calculated to prevent improper disclosure. All persons to

whom protected material is disclosed will be given a copy of this order sealing the documents by the person making the disclosure.
