**TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:**

On April 23, 2010, petitioner **Robert Dominic Mannix** sought an extension of time to comply with the order assessing disciplinary costs (\$5,019) based on financial hardship. (Rules Proc. of State Bar, rule 282.) Petitioner proposes a monthly installment payment of \$200 per month until the costs are paid in full.

On May 13, 2010, Deputy Trial Counsel Mark Hartman of the Office of the Chief Trial Counsel of the State Bar of California filed a response and does not oppose the payment plan suggested by petitioner.


In view of petitioner's financial hardship and good cause appearing, petitioner's request for extension of time to pay the disciplinary costs of \$5,019 is **GRANTED**. **Petitioner must pay \$200, due on the 1<sup>st</sup> of each month, beginning on July 1, 2010, and continuing until the**



**disciplinary costs are paid in full.** It is also ordered that if petitioner fails to pay any installment within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment. (Rules Proc. of State Bar, rule 286.)

IT IS SO ORDERED.


